Clayton Visual Arts, Inc. seeks artists for the 2020 monthly exhibit season, which begins in February at The Clayton Center in Clayton, NC. CVA exhibits original artwork in any 2-dimensional media.

Interested artists or artist-groups are invited to apply for a show by sending a **resume**, a completed **application form**, a **portfolio of 4-6 images**, and a non-refundable **application fee of \$10** to Clayton Visual Arts, Inc. (CVA), P.O. Box 698, Clayton, NC 27528.

The images must be representative of the type of work the artist plans to exhibit.

- Each image should show a single piece of art with **minimal background**.
- The images must be submitted in **jpg format**.
- All images should be high quality with the **longest side of about 2000 pixels**.
- The images should be delivered by email, on a CD, or from a specified website if they meet the size limit.

Complete the information on the entry form below and submit <u>application form</u> plus <u>check for</u> \$10 (made to CVA with *Exhibits Committee* in the memo line). Artists may email images or website link to: Exhibits Committee Chair, Medrith Nuttle at <u>medrith_nuttle@sbcglobal.net</u> Artist's resume can be submitted by mail or via email using pdf format.

(If mailing an image CD, return of CD cannot be guaranteed without enclosed return postage.)

All items (**resume**, **portfolio of images**, **application**, and **fee**) must reach the committee no later than 5:00 pm Friday, October 18, 2019.

To ensure a good variety of exhibitors, we ask that artists skip two years between exhibits. This means that if you had a show with us in 2018, please wait until autumn of 2020 (next year) to apply for a show in 2021. If your show was in 2019, please wait until 2021 to apply for 2022.

The non-refundable application fee of \$10 must be received (along with form, resume, and images) by the Exhibits Committee before the entry will be considered. Make checks/money orders payable to: Clayton Visual Arts, Inc., (or CVA). Please do not send cash.

Selected applicants will be provided a contract detailing terms and conditions for exhibiting at The Clayton Center. A \$35 exhibit fee (\$25 for CVA members) is due at the time of execution of the contract. Accepted applicants will be notified in early November 2019.

Exhibits usually consist of a total of 40-50 pieces and are scheduled by calendar months. (For shows of multiple artist the amount would be less, e.g. 2 artist 20-25 each, 3 artists 12-15.) Shows may be multi-person shows and the number of pieces for each artist will be determined by the Exhibits Committee. The shows hang in the main lobby of The Clayton Center, 111 E Second St., which is free and open to the public daily during business hours.
